

# Public Notice to Boil Water

On 6/30/2025, Dog Ridge Water Supply Corporation (PWS ID #0140044) has issued a Boil Notice due to low pressure caused by pump failure.

The Texas Commission on Environmental Quality (TCEQ) has required our customers living on the following roads to boil their water:

To ensure the destruction of all harmful bacteria and other microbes, water for drinking, cooking, and making ice should be boiled and cooled prior to use. The water should be

brought to a vigorous rolling boil and continue boiling for two minutes. In lieu of boiling, you may purchase bottled water or obtain water from some other suitable course.

When it is no longer necessary to boil the water, the water system officials will notify you that the water is safe for consumption. Instructions to discontinue boiling will be issued in the same manner as this notice.
